According to Mary Langworthy, Executive Director, the recently approved 501(c) (3) designation from the Internal Revenue Service is critical to the Foundation's goal to attract and direct tax-deductible gifts and contributions for the benefit of Carver County. Individuals, corporations and other foundations can give directly to The Community Foundation for Carver County.

“This foundation provides an opportunity for donors to give back locally to causes they care about most in Carver County. We are a channel through which donors can direct funds to local nonprofits and other initiatives in our communities that are important to them,” Langworthy said. “The organization is uniquely positioned to ‘connect the dots’ and make the most of local donor resources – addressing gaps in funding now and in the future.”

“A rapidly growing community like Carver County depends upon the collective planning and investment of the people who live and work in it to remain vibrant and healthy,” said Bob Roepke, Chaska, who serves as chair of the Foundation. “Like the Minneapolis Foundation or the St. Paul Foundation, our intention is to make a difference in people's lives, each and every day, right here in Carver County.”

“We are committed to helping individuals, families and businesses achieve their charitable financial goals, including offering tools and resources to make giving easy, flexible and effective,” Langworthy said.

“Sharing resources to help others is one of the most rewarding things a person or business can do,” Roepke added. “The opportunities to improve our collective quality of life are endless.
